CITY OF READING

Restructuring of Finance and Human Resources Departments
Reestructura de Departamentos de Finanzas y Recursos Humanos

Question

“Shall the Home Rule Charter be amended by combining the City of Reading Human Resources and Finance Departments to form one department called Department of Administrative Services, headed by the Director of Administrative Services, appointed by the Mayor and approved by City Council, which will make the Director of Administrative Services responsible for the administration of the City of Reading personnel and finance departments and their functions as set forth in the Administrative Code? The amendment will require the Director of Administrative Services to have at a minimum a Bachelor’s degree in public administration, finance, economics, political science or other related field and a minimum of eight (8) years related experience. The approved amendment would eliminate the Home Rule Charter Section 705 Human Resources and require the renumbering of Article VII Personnel System. It will also require replacing all references to the Director of Finance and Director of Human Resources with Director of Administrative Services in the City of Reading Home Rule Charter.”

¿Debe ser enmendado el Estatuto de Autonomía de la Ciudad de Reading para combinar el Departamento de Recursos Humanos y el Departamento de Finanzas para formar un departamento llamado el Departamento de Servicios Administrativos, encabezado por el Director de Servicios Administrativos, nombrado por el Alcalde y aprobado por el Consejo de la Ciudad lo cual haría el Director de Servicios Administrativos responsable por la administración del personal de la Ciudad de Reading y el Departamento Financiero y sus funciones así como indica el Código Administrativo? La enmienda requiere que el Director de Servicios Administrativos tenga de mínimo un bachillerato en administración pública, finanzas, economía, ciencia política o campo relacionado y un mínimo de ocho (8) años de experiencia relacionada. La enmienda aprobada eliminaría la Sección 705 del Estatuto de Autonomía Recursos Humanos y requiere la reenumeración del Artículo VII Sistema Personal. También requiere reemplazar todas referencias al Director de Finanzas y Director de Recursos Humanos con el Director de Servicios Administrativos en el Estatuto de Autonomía de la Ciudad de Reading.
