## Local Economic Revitalization Tax Assistance (LERTA) Act Program Guidelines

Except for good cause shown, the Board will not approve a LERTA application if the Subject Property is located in an area of the County which has not been designated with a Future Land Use ("FLU") designation of Existing Development, Designated Growth, or Future Growth on the comprehensive plan most recently adopted by the County.

Within sixty (60) days after securing the building permit from the Municipality, the Applicant shall forward to the Director of Community and Economic Development a LERTA program application which shall include the following information:

- (1) Any LERTA application materials and supplemental information submitted to the Municipality;
- (2) The address(es) and tax parcel identification number(s) of the Subject Property;
- (3) The current and proposed use(s) of the Subject Property;
- (4) The cost of the Improvement;
- (5) The date the Municipality approved the building permit for the Improvement;
- (6) A copy of the fully executed ordinance(s), and resolution(s) exhibiting approval of the LERTA for the Subject Property; and
- (7) Written certification by the Municipality that:
  - (a) all applicable and associated building and other municipal fees have been paid or that an approved agreement is in place,
  - (b) all required permits and land development approvals have been obtained by the Applicant.

- (a) Failure to pay any non-exempt real estate taxes by the last day of the time period to pay such taxes in the penalty period.
- (b) An appeal taken from the assessed value of a Subject Property, other than an appeal in accordance with 72 P.S. § 4727.

I certify that the applicant is not in arrears with the IRS, Commonwealth of Pennsylvania, and/ or County of Berks for taxes.

I acknowledge the above Certification and truthfulness of the information included in this application.

### Please Attach all documents as referenced in the Program Guidelines:

If the Improvement has not been completed by the last day of the twenty-fourth (24th) month following adoption of the resolution granting approval of the tax exemption, that resolution will expire unless Applicant obtains an extension by submitting a letter to the Director of Community and Economic Development explaining the reasons why an extension should be granted. The granting of an extension of time shall be at the discretion of the Board.

Failure to submit a complete application may result in a delay or inability to approve a LERTA to the
subject parcel(s).
