#### Welcome & Introductions

Vice Chairperson Lyn O'Hare called the meeting to order at 12:25P.M. at the Berks County Department of Emergency Services, Direct Link Technology Center, Multi-Purpose Room, Reading PA. Call-in provision was made available.

#### Minutes from the September 2019 Meeting

Megan Young-Kraft reports that 339 facilities reported for 2018, with 26 that have not reported. There were 11 facilities that reported and did not pay fees for 2019. Total in fees collected for the 2019 at the time of the meeting is \$112,700.

- Megan Young-Kraft shared that she attended the inspections of all three Bulk Chemical facilities with the EPA. Harry Adams shared that while preliminary suggestions were made as to the storage of chemicals, the full report has not been returned yet.

A motion was made by Robert May, seconded by Kevin Docherty to adjourn. The motion passed, meeting adjourned.
