Minutes from the March 2021 meeting

Mike Rowley advised the March 2021 minutes had listed him as a member but he is a guest. The change was noted and the minutes corrected.

A motion was made by Donnie Swope, seconded by Gary Moulder to approve the minutes. The motion passed and the minutes for March 2021 were approved.

Correspondence

- A letter was received from Speedway regarding the location at 200 Lancaster Ave.,
 Reading; no chemicals above reporting threshold are on site
- A letter was received from American Tower Corporation that they will no longer be reporting inventory on behalf of the tenants at their sites.
- A letter was received from G&L Transportation regarding their location at 980 Hoffmansville Rd., Bechtelsville advising their underground gas and diesel tanks were removed, and a 1,000 gallon heating oil tank was installed on the property.

 A letter and storage tank report forms were received from Superior Plus Energy Services regarding their location at 1112 Carbon St., Reading. All four bulk petroleum storage tanks are empty and out of service.

EHS / Tier II Submission Status

Megan Young-Kraft reported the first round of updates to the Tier II Manager system have been completed. This included the ability for admin to request edits through the system and admin being able to manage the first due fire departments.

Income for 2021 year-to-date is \$110,450. 349 reports for the 2020 report year have been received with 22 facilities not yet reported. About 70 emergency response plans have been received; up from the previous years thanks to the system's reminder after a report is submitted.

Hazmat Team Report

Phil Salamone reported 5 responses by the county spill trailers and no full team responses. HAZCAT training was completed over four days in May, and a DOT container course was held in June. The team is looking at new helmets and speaker microphones. New radiological and gas meters were purchased.
