Good & Welfare


Donnie Swope reported an increase in hazmat responses. In the HMERP Assessment for 2017, there were roughly 70 hazmat responses, most of which were petroleum related

products. They only required notification to the on duty EMA/SOG supervisor. In 2018, there were over 95 hazmat responses.

Terry Sturgis advised the spotted lanternfly permits will soon be required by affected businesses.

A motion was made by Megan Young-Kraft, seconded by George Dula to adjourn. The motion passed, meeting adjourned.
